Sanction is hereby accorded to the constitution of a State Health Agency/ Governing Council, Executive Committee and District Implementation Unit (DIU), for implementation of Ayushman Bharat-Pradhan Mantri Rashtriya Swasthya Suraksha Mission (PMRSSM) in the State:-

**The role & responsibilities/terms of references of the State Health Agency (SHA)/Governing Council:-**

All key functions relating to delivery of services under PMRSSM shall be performed by the SHA viz. data sharing, verification/validation of families and members, awareness generation, monitoring etc. The SHA shall perform following activities through staff of SHA/implementing Support Agency (ISA);-

- I. Policy related issues of State Health Protection/Insurance scheme and its linkage to PMRSSM;
- II. Convergence of State Schemes with PMRSSM;
- III. Approving institutional arrangements for implementing the programme including approving selection of other agencies for different elements of the programme;
- IV. Adopting necessary operational guidelines in consultation with NHA, where necessary;
- V. Overall monitoring of all aspects of the programme from design implementation & delivery of services;
- VI. Monitoring the Performance of hospitals/service providers;
- VII. Overall financial supervision of the programme including price packages; and
- VIII. Examining the independent evaluation of the programme.



The role & responsibilities/ terms of reference of the Executive Committee shall be to:-

- i. Select Health insurance providers and Health Service Providers under PMRSSM;
- ii. appoint persons to posts carrying the scale of pay or on consolidated pay after, obtaining the prior approval of the Government for creation of posts and Chairman of Governing Body of the Society;
- iii. exercise control and discipline over the employees of the Society;
- iv. propose bye-laws for any of the matters for which they may be made, for consideration and approval by the Governing Body;
- v. initiate action to recover any amount due to the Society;
- vi. appoint from time to time, such committees as may be needed and to assign or delegate thereto such powers duties and functions as it may deem fit;
- vii. arrange the audit for the society annually;
- viii. present every year in proper time to the Governing Body, and annual report, an annual budget and audited annual accounts for its consideration and approval; and
- ix. perform all such acts & duties and exercise all such powers as may be delegated or assigned to it by the Governing Body.

The role & responsibilities/terms of references of the District Implementation Unit:-

- I. District implementation Unit (DIU) shall support the implementation of the scheme in every district included under the scheme;
- II. A DIU shall be chaired by the Deputy Commissioner/District Magistrate/Collector of the District;
- III. This unit shall coordinate with the Implementing Support Agency/Insurer and the Network Hospitals to ensure effective implementation
- IV. DIU shall send review reports periodically; and
- V. DIU will also work closely and coordinate with District Chief Medical Officer and his or her team.


